

**DISCLOSURE ON THE PURCHASE OF TREASURY SHARES  
FROM 31 JULY TO 4 AUGUST 2017**

*Segrate, 7 August 2017* - Arnoldo Mondadori Editore S.p.A. (LEI Code 815600049A1F9AFE6666) announces the purchase on the MTA (Electronic Stock Market), in the period from 31 July to 4 August 2017, of no. 26,500 ordinary shares (equal to 0.010% of the share capital) at an average unit price of Euro 1.8224 for a total amount of Euro 48,293.50.

These transactions were made under the authorization to purchase treasury shares approved by the Shareholders' Meeting on 27 April 2017 (previously disclosed pursuant also to art. 144 bis of Consob Regulation 11971/99 and to art. 132 of Legislative Decree 58/98).
