

**DISCLOSURE ON THE PURCHASE OF TREASURY SHARES  
FROM 10 TO 14 SEPTEMBER 2018**

Segrate, 17 September 2018 - Arnaldo Mondadori Editore S.p.A. (LEI Code 815600049A1F9AFE6666) announces the purchase on the MTA (Electronic Stock Market), in the period from 10 to 14 September 2018, of no. 14,500 ordinary shares (equal to 0.006% of the share capital) at an average unit price of Euro 1.4256 for a total amount of Euro 20,671.90.

These transactions were made under the authorization to purchase treasury shares approved by the Shareholders' Meeting on 24 April 2018 (previously disclosed pursuant also to art. 144 bis of Consob Regulation 11971/99 and to art. 132 of Legislative Decree 58/98).
