

**DISCLOSURE ON THE PURCHASE OF TREASURY SHARES
FROM 21 TO 25 OCTOBER 2019**

Segrate, 28 October 2019 - Arnoldo Mondadori Editore S.p.A. (LEI Code 815600049A1F9AFE6666) announces the purchase on the MTA (Electronic Stock Market), in the period from 21 to 25 October 2019, of no. 51,000 ordinary shares (equal to 0.020% of the share capital) at an average unit price of Euro 1.923 for a total amount of Euro 98,075.30.

These transactions were made under the authorization to purchase treasury shares approved by the Shareholders' Meeting on 17 April 2019 (previously disclosed pursuant also to art. 144 bis of Consob Regulation 11971/99, to art. 5 of Regulation (EU) 596/2014 and to art. 132 of Legislative Decree 58/98).
